In consideration of, and as part of payment for, the right to participate in these activities and services arranged for me by Miracle Ranch, I have and do hereby assume all the above-mentioned risks and any other risks reasonably arising out of my participation in the above-mentioned activities. I will indemnify and hold harmless Miracle Ranch, its owners, employees, and all other representatives from all liability, actions, debts, claims and demands of every kind and nature whatsoever, losses, damages and costs including but not limited to bodily injury or property damage, which may arise out of or in connection with my participation in activities associated with Miracle Ranch.

The terms thereof shall serve as a release and assumption of risk and be binding upon all my heirs, executors, administrators and for all members of my family, including any minors. This indemnification shall include attorneys' fees incurred in defending any claim or judgment and incurred in negotiating any settlement regarding any claim.

I understand that any photos taken by Miracle Ranch staff or sent to Miracle Ranch by me will become the property of Miracle Ranch. I release for marketing purposes all such photos. These photos may be used on the Miracle Ranch website, in brochures or in other marketing materials.
